Promotion Period:	The Promotion opens at 9am (AEST) on Monday 13 April 2026 and closes at 11.59pm (AEST) on Sunday, 31 May 2026. Late entries will not be accepted.
Who can enter:	Entry is open only to show attendees/visitors who are over the age of 18 years.
