

Tickets for shows at Croxton Bandroom are sold subject to the following conditions and patrons may be refused entry or removed from the premises for failure to abide by said conditions. Conditions of Entry may change or be varied without notice.

THE RIGHT OF ADMISSION IS RESERVED AND IS SUBJECT TO THIS CODE OF CONDUCT, LIQUOR LICENSING LAWS AND THE TERMS AND CONDITIONS AGREED TO AT TIME OF PURCHASE IRRESPECTIVE OF THAT PERSON BEING IN POSSESSION OF A VALID TICKET FOR AN EVENT.

MANAGEMENT AT ALL TIMES RESERVES THE RIGHT TO REFUSE ENTRY TO THE VENUE AND TO REMOVE PATRONS FROM THE VENUE.

Patrons must have purchased, or intend to purchase if available, a ticket to the event. Tickets that have been bought from third party resellers, cancelled or already scanned at entry are not, or may not be, valid and patrons may be refused entry or required to purchase a valid ticket, if available. It is the patrons responsibility to ensure that they have purchased a valid ticket in order to be permitted entry.

All shows are over 18 only unless stated. Minors will not be allowed access to any show or event even if accompanied by an adult. Patrons are required to have appropriate, valid, original proof of age documents to show at the door (photos and scans of documents are not accepted as valid), failure to provide such may result in refusal of entry. Valid proof of age is required for entry, as per the requirements of our liquor licence. Information about Proof of age can be found at VCGLR website

The Croxton Bandroom follows RSA guidelines and operates under the conditions of its liquor licence, as such Responsible Service of Alcohol legislation applies to all patrons and ticket holders. Patrons who are intoxicated, suspected of being intoxicated or otherwise under the influence of drugs or alcohol may be refused entry or removed from the venue.

Appropriate clothing must be worn at all times. Footwear must be worn and wearing thongs, slides, sandals etc may result in refusal of entry. Steel cap boots are not permitted. Any item deemed offensive or, likely to cause offence, may result in refusal of entry.

Patrons may have their bag searched at entry, prohibited items include, but are not limited to: Liquids (empty water bottles are permitted and can be filled at the bars), professional style cameras and recording devices, alcohol, drugs, weapons, spray paint. Any large items such as umbrellas, bags larger than A4 size, skateboards etc are required to be cloaked.

Patrons are encouraged to take responsibility for their own safety, and to report any inappropriate, illegal or inappropriate behaviour to security or management.

The Croxton has a zero tolerance policy towards harassment, aggressive or violent behaviour. This includes but is not limited to, body shaming, ableism, racism, sexism, homophobia and transphobia, and such behaviour will result in your removal from the venue.

Moshing, crowd surfing or other activities are not encouraged or endorsed by the venue and may result in removal.

Tagging or graffiti will not be tolerated and will result in your removal from the venue.

Patrons Attending the Croxton consent to being filmed by CCTV, and may be filmed by Artists who are recording their show.

Professional style cameras, recording or film equipment, except for phones or small handheld cameras are not permitted. You agree not to record or transmit, or aid in recording or transmitting, any description, account, picture, or reproduction of the event without the express permission of the artist. The performance remains the property of the artist.

Cloak room facilities are available, however all items are cloaked at the risk of the owner and no responsibility or liability is accepted for any damage or loss.

#### **SMOKING AND ILLICIT SUBSTANCES**

Illicit substances along with the smoking of cigarettes, cigars, vaporisers and e-cigarettes will not be permitted inside any part of our Venue (including toilets, backstage and dressing rooms). Designated smoking areas are nominated at the front of the Venue.
