The Professional Certificate in Showstop® Procedure

The Professional Certificate in Showstop® Procedure is a one-day course, designed for experienced event professionals who work within a strategic, tactical or operational role at events, with responsibility for the safety of crowds.

At its core, the Showstop® Procedure enables immediate intervention to stop a live performance if there is a credible threat to life safety (e.g. crowd related, structural failure, mass public order, fire or terrorism).

The Showstop® Procedure is a proven, formalised, predefined and robust process, that enables a swift response to a imminent or immediate threat to life safety during a live performance or sporting event. The Showstop® Procedure can be incorporated into the full

range of events to enhance emergency preparedness.

The Showstop® Procedure enhances event emergency preparedness using a system wide approach that complies with reasonably practicable safety standards, ensuring a dynamic response capability to undesirable occurrences.

The Showstop® Procedure demonstrates that the event organiser, or venue operator, as part of their risk mitigation and emergency preparedness, have considered the foreseeability of harm, implemented proportionate control measures and appointed competent personnel, adhering to their moral and legal obligations.

WHY?

History evidences a catalogue of events where tragic outcomes could have been prevented.

It is therefore foreseeable that the risk of an undesirable occurrence, during a live performance or sporting event is ever present. In many countries there is a legal requirement to plan and prepare for emergencies as well as a legal duty of care.

The Showstop® Procedure is an essential component for public safety, emergency preparedness, legal compliance, and operational readiness, for event organisers, venue management and emergency services, in the face of undesirable occurrences, during a live performance or sporting event.
